

By checking the "I agree to the collection and processing of my personal data" box and clicking "Download," your personal data will be added to the "Individuals" personal data database of ain.ua to ensure the proper implementation of relations with ain.ua, proper provision of services, correspondence, administrative and legal relations.

Ain.ua maintains the database. Composition and content of personal data mean information about you provided/specified by you and/or indicated in the documents provided by you. Individuals who have been granted access are individuals associated with ain.ua and partners of ain.ua.

You are a personal data subject according to the Law of Ukraine "On Personal Data Protection." Under Article 8 of the Law of Ukraine "On Personal Data Protection," a personal data subject has the right to:

- 1) know about the sources of collection, location of their personal data, the purpose of their processing, location or place of residence (stay) of the owner or manager of personal data or to give a corresponding order to obtain this information to persons authorized by them, except in cases prescribed by law;
- 2) receive information about the conditions for granting access to personal data, including information about third parties to whom their personal data is transferred;
- 3) access their personal data;
- 4) receive, no later than thirty calendar days from the date of receipt of the request, except in cases provided for by law, a response on whether their personal data is processed, as well as to receive the contents of such personal data;
- 5) submit a reasoned request to the personal data controller with an objection to the processing of their personal data;
- 6) submit a reasoned request to change or destroy their personal data by any owner and administrator of personal data if such data is processed illegally or is inaccurate;
- 7) protect their personal data from unlawful processing and accidental loss, destruction, damage due to intentional concealment, failure to provide, or untimely provision, as well as to protect against the provision of information that is inaccurate or discrediting the honor, dignity, and business reputation of an individual;
- 8) file complaints regarding the processing of their personal data with the Ukrainian Parliament Commissioner for Human Rights or a court;
- 9) apply legal remedies in case of violation of the legislation on personal data protection;
- 10) make reservations regarding the restriction of the right to process their personal data when giving consent;
- 11) withdraw consent to the processing of personal data;
- 12) know the mechanism of personal data automatic processing;
- 13) seek protection against an automated decision that has legal implications for them.

registration, accumulation, storage, adaptation, modification, updating, use and distribution (distribution, implementation, transfer), depersonalization, destruction) of your personal data in the files and/or through the information and telecommunication system of the ain.ua personal data database to ensure the proper implementation of relations with ain.ua, proper provision of services, correspondence, administrative and legal relations, and confirm that you have been notified of the inclusion of your personal data in the ain.ua "Individuals" personal data database, the purpose of processing, the composition and content of personal data, individuals who have been granted access to personal data, my rights as a personal data subject.
